Cases of Note

Crime Defence:

R v K [2022]

Successfully made submissions on Crown's disclosure failures and Crown offered no evidence.

R v I [2022]

Represented a Defendant charged with burglary non-dwelling. Jury were hung and Crown offered no evidence.

R v T [2022]

Represented a Defendant charged with assaulting a security guard who had mistaken the Defendant to be someone else and then assaulted him. Meeno successfully got an acquittal.

R v TY [2023]

Successfully secured a stand-alone suspended order for a Defendant who pleaded guilty to sexual assault.

R v AJ [2023]

Defendant was convicted of sexual assault after trial. The case was committed for sentence to the Crown Court, the judge was minded to give him a longer sentence but with Meeno's submissions, he was sentenced to 4 months custody.

Extradition**Poland v M [2022]**

Meeno made submissions on Article 8 grounds, which successfully secured discharge for client who was due to be extradited to Poland.
