Murders

R v LL

Led junior in double murder and attempted murder at Central Criminal Court.

R v MN

Led Junior in murder at Central Criminal Court.

R v AA

Led Junior in murder at Central Criminal Court.

R v SR

Led Junior in murder at Central Criminal Court.

Attempted Murder

R v ZW

Led Junior in attempted murder at Kingston Crown Court. Also charged with Firearms offences. Acquitted of Attempted murder.

Firearms cases

RVHB

Junior alone. Defendant charged with Possession of a Firearm with Intent to endanger life. Central Criminal Court. Acquitted of all charges.

R v OL

Junior alone. Defendant charged with Possession of a Firearm with Intent to endanger life.

Acquitted of all charges

R v JP

Junior alone. Defendant charged with possession of an imitation firearm. Acquitted of all charges.

Violence and dishonesty cases

R v KI

Junior Alone. Defendant charged with s.18 GBH (using car as a weapon). Convicted of s.20. Snaresbrook CC

R v KL

Junior alone. Defendant charged with s18 in a domestic context. Acquitted of all charges. Snaresbrook CC.

R v SR

Junior alone. Defendant charged with Aggravated Burglary. Acquitted of all charges. Snaresbrook Crown Court.

R v JL

Junior alone. Armed Robbery of sex workers on numerous occasions.

Drugs cases

R v FC

Conspiracy to Supply Class A – encrochat case. Junior Alone. Croydon CC

R v II

Junior alone. Conspiracy to supply A. Isleworth CC.

R v JK

Junior alone. Possession with Intent to supply Class A. Guildford CC.

Court Martial Cases

R v DLT – A member of the RAF Police Flt was charged with Sexual Assault. Following lengthy legal arguments both written and oral submissions - the Crown offered no evidence.

R v ST

A member of the RAF was charged with s.20 GBH that occurred during the course of a football match. He stated he was acting in self defence and was acquitted after a 5-day trial at Catterick Court Martial Centre.

R v MD

A member of the British Army charged with ABH in a domestic context. Mixed verdicts after a 4 day trial.

R v AA

A member of the British Army charged with 3 separate sexual assaults and indecent exposure. Acquitted after a 4 day trial.

R v SL

A member of the Royal Navy charged with theft. He pleaded guilty but unusually was not dismissed from Service.

R v ZS

A senior NCO in the British army was charged with ABH and GBH. Defendant acquitted of ABH at half time and GBH following a verdict from the Board.
