# Criminal Defence

# Cases of Note

#### **CRIME - DEFENCE**

#### R v M (2024) Southwark Crown Court

Instructed as junior alone to represent M, charged with attempted murder. The defendant had complex mental health issues. Sarah called expert psychiatric evidence and successfully persuaded the jury that the defendant did not intend to kill the victim.

#### R v C (2024) Croydon Crown Court

Instructed as junior alone to represent C who was unanimously acquitted of all six counts including supplying class A drugs, that he faced following a trial at Croydon Crown Court. The Defendant accepted possession of over 5kg of MDMA, cocaine and ketamine but successfully ran a modern slavery defence.

#### R v C (2024) Basildon Crown Court

Instructed as junior alone to represent C who was charged with modern slavery offences and armed kidnap of a child. C was unanimously acquitted of all charges in less than one hour.

#### R v A (2024) Winchester Crown Court

Instructed as junior alone to represent A who was charged with drug supply offences. Successfully ran a defence of duress.

#### R v P (2023) Kingston Crown Court

Instructed as led junior to represent P, charged with murder.

#### R v M (2022) Croydon Crown Court

Instructed as led junior to represent M, charged with drug supply offences involving Encrochat evidence.

#### R v P (2023) Kingston Crown Court

Instructed as led junior to represent P, charged with murder.

#### R v M (2022) Croydon Crown Court

Instructed as led junior to represent M, charged with drug supply offences involving Encrochat evidence.

#### R v A – 2022 – Croydon Crown Court

Instructed to represent A, charged with Possession with Intent to Supply drugs. A accepted possession of a large quantity of cannabis but argued he had bulk bought during lockdown. Jury acquitted unanimously after just 20 minutes of deliberation.

#### R v R – 2020 – St Albans Crown Court

Instructed to represent R, charged with aggravated burglary and wounding with intent.

#### R v P – 2020 – Huntingdon Crown Court

Defended a man of good character, charged with ABH and 2 batteries against his wife, successfully arguing self-defence.

#### R v B – 2019 – Kingston Crown Court

Successful defence of a man charged with assaulting a police officer and a racially aggravated public order offence against an Uber driver, both of which were captured on CCTV.
